## BAC Resolution No. PAD-OC-03, s. 2023

- WHEREAS, the Agricultural Training Institute has approved the Purchase Request (P.R.) No.

  PAD (BPP) FUND 2023-04-25 dated 25 April 2023 for the lease of the venue with meals, accommodations, and other services for the conduct of Binhi ng Pag-Asa Program (BPP)

  National Training of Trainers (TOT) on Leadership on 9-12 May 2023 at CALABARZON with Approved Budget for the Contract (ABC) amounting to Two Hundred Eighty Thousand Pesos Only (Php 280.000.00) in accordance with the approved End-user's Project Procurement Management Plan (PPMP);
- WHEREAS, as a general rule, all procurement shall be done through competitive bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any alternative method of procurement;
- WHEREAS, one of the functions of BAC is to recommend to the Head of Procuring Entity (HOPE) the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;
- **WHEREAS**, the above-cited nature of P.R. based on its corresponding specifications and terms is within the coverage of Section 53. 10 and Annex "H" D-9 of the 2016 Revised IRR of RA 9184;
- **WHEREAS**, as a general rule for alternative methods of procurement, advertisement, and posting as prescribed in Section 21.2.1 of the IRR, may be dispensed with, except those provided in Section 54.2 of the IRR;
- **WHEREAS**, the Bids and Awards Committee through its procurement coordinator sends three requests for quotations/proposals to suppliers of known qualifications;
- **WHEREAS**, the receipt of 1 quotation/proposal is sufficient to proceed with the evaluation thereof;
- WHEREAS, the supplier with the lowest quotation/proposal must undergo and be rated according to the Table of Rating Factors for Lease of Venue as indicated in Annex H, Appendix B, Table C of 2016 Revised IRR of RA 9184 for the determination of the reasonableness of rental rates;
- **WHEREAS**, ATI ensures that the objectives and purpose of the procurement do not constitute an unnecessary, excessive, extravagant, or unconscionable expenditure;
- WHEREAS, ATI-BAC shall validate the technical, legal, and financial capability of the supplier/s by
