A RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING AN ALTERNATIVE METHOD OF PROCUREMENT – NEGOTIATED PROCUREMENT - SMALL VALUE PROCUREMENT AND AWARD TO L.Q.N. GENERAL MERCHANDISE.

WHEREAS, the Agricultural Training Institute Director/Head of Procuring Entity had approved Purchase Request (P.R.) No. PAD (HVCDP) FUND 2023-04-28 dated 19 April 2023 to procure Various Hardscape Materials for the Area Landscaping to be used during the ATI-ATIHan 2023: Pistang Ani ng Bayan (Harvest Festival and Field day on 31 May 2023. Approved Budget for the Contract (ABC) of Sixty Nine Thousand One Hundred Fifty Pesos Only (Php 69,150.00) in accordance with the End-user’s Project Procurement Management Plan (PPMP);

WHEREAS, as a general rule, all procurement shall be done through competitive bidding except whenever justified by the conditions in order to promote economy and efficiency, may resort to any alternative method of procurement;

WHEREAS, one of the functions of BAC is to recommend to the Head of Procuring Entity (HOPE) the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;

WHEREAS, the above-cited Purchase Request of Various Hardscape Materials for the Area Landscaping, is not covered by Shopping under Section 52 of the IRR of RA 9184;

WHEREAS, the amount involved is within the threshold of Negotiated Procurement - Small Value Procurement as an Alternative Method of Procurement indicated in Annex "H" of 2016 Revised IRR of RA 9184 for National Government Agencies (NGA's);

WHEREAS, invitations be posted thru PhilGEPs and procurement entity’s website and other conspicuous places and send three requests for quotations/proposals to suppliers, contractors, and consultants of known qualifications;

WHEREAS, the prospective supplier must have a satisfactory feedback from the previous contract with ATI or must not have complained of any unsatisfactory service(s);

WHEREAS, the receipt of one (1) quotation/proposal is sufficient to proceed with the evaluation thereof;

WHEREAS, ATI ensures that the objectives and purpose of the procurement do not constitute an unnecessary, excessive, extravagant, or unconscionable expenditure;

WHEREAS, ATI-BAC shall validate the technical, legal, and financial capability of the supplier/s by submission of relevant documents or through other means of exercising due diligence prior to the recommendation of award to the Head of Procuring Entity (HOPE).

NOW THEREFORE, in the consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby **RESOLVE AS IT HEREBY RESOLVED** to:

- 1. Recommend Alternative Method of Procurement through Negotiated Procurement-Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of 2016 Revised IRR of RA 9184 for the above-cited goods/services/infrastructure projects/consulting services; and**

2. Recommend the approval and award by the ATI Director IV of this Resolution and Purchase Order/Contract to L.Q.N. General Merchandise with a contract amount of Php 69,000.00
