**A RESOLUTION DECLARING GREEN OPTIONS AGRICULTURAL AND ENVIRONMENTAL BUSINESS CENTER AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR SEEDS (LOT 1) AND AGRICULTURAL GROW KITS (LOT 3) WHILE MARABE ENTERPRISES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR TOOLS AND EQUIPMENT (LOT 2), AND FERTILIZER, SOIL, AND COMPOST (LOT 4) (PHILGEPS REF. NO. 8557293/ ITB NO. ATI-CO-2023-05)**

**WHEREAS**, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity abides by the standard set forth by the said act;

**WHEREAS**, Section 10, Rule IV of the IRR of the 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under Rule XIV;

**WHEREAS**, the Procurement of Agricultural Supplies, Materials, and Equipment, not being an exemption, must necessarily pass through competitive bidding;

**WHEREAS**, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with an Approved Budget for the Contract Amounting to **Four Million Two-Hundred Ninety-One Thousand Two Hundred Fifty Pesos (Php 4,291,250.00)** on PhilGEPS Website (PHILGEPS REF. NO. 9557293/ ITB NO. ATI-CO-2023-05) and the ATI Website with the following lots.

**WHEREAS**, in response to the said posting, two (2) prospective bidders bought the bidding documents from the BAC Secretariat and submitted their bid proposals during the bid opening held on April 3, 2023;

**WHEREAS**, during the Bid Opening, it was found that having complied with all the eligibility/technical and financial requirements, bidders were rated as “ELIGIBLE” to participate in the bidding and thus rated as “PASSED”;

**WHEREAS**, the Technical Working Group (TWG) for Goods and Services conducted a careful examination, validation, and verification of all eligibility documents, technical and financial documents required including post-qualification documents as required by RA 9184 and its Implementing Rules and Regulations (see attached TWG’s Bid Evaluation Report and Post-qualification Report);

**WHEREAS**, Green Options Agricultural and Environmental Business Center is the Lowest Calculated and Responsive Bidder for the Lot 1 (Seeds) and Lot 3 (Agricultural Grow Kit) while Marabe Enterprises is the Lowest Calculated and Responsive Bidder for Lot 2 (Agricultural Tools and Equipment) and Lot 4 (Fertilizer, Soil and Compost) with the amount as follows:

**WHEREAS**, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG's recommendation and declared **Green Options Agricultural and Environmental Business Center is the Lowest Calculated and Responsive Bidder for the Lot 1 (Seeds) and Lot 3 (Agricultural Grow Kit) while Marabe Enterprises is the Lowest Calculated and Responsive Bidder for Lot 2 (Agricultural Tools and Equipment) and Lot 4 (Fertilizer, Soil and Compost);**

**NOW, THEREFORE**, in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby **RESOLVE AS IT HEREBY RESOLVED** to:

1. Declare Green Options Agricultural and Environmental Business Center as the **LOWEST CALCULATED AND RESPONSIVE** is the Lowest Calculated and Responsive Bidder for the Lot 1 (Seeds) and Lot 3 (Agricultural Grow Kit) amounting to Six Hundred Eleven Thousand Six Hundred Forty-Two Pesos and 50/100 (PhP 611,642.50) and Eight Hundred Fifty-Five Thousand Pesos (PhP 855,000.00) respectively;
2. Declare Marabe Enterprises as the Lowest Calculated and Responsive Bidder for Lot 2 (Agricultural Tools and Equipment) and Lot 4 (Fertilizer, Soil and Compost) amounting to One Million Eight Hundred Sixty-Four Thousand Six Hundred Forty-Six Pesos and 63/100 (PhP 1,864,646.63) and Five Hundred Two Thousand Forty Pesos and 75/100 (PhP 502,040.75) respectively;
3. Recommend for the approval of the award of the said Contract to **Green Options Agricultural and Environmental Business Center for the Lot 1 (Seeds) and Lot 3 (Agricultural Grow Kit) while Marabe Enterprises for Lot 2 (Agricultural Tools and Equipment) and Lot 4 (Fertilizer, Soil and Compost);**
4. Recommend for Approval by the ATI Director IV the foregoing findings/ recommendations.
