LINE FROM ATS ROOM TO MAIN PANEL OF ATI-CO MAIN BUILDING
(PHILGEPS REF. NO. 9813857/ ITB NO. ATI-CO-2023-07)**

WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act" created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity abides by the standard set forth by the said act;

WHEREAS, Section 10, Rule IV of the IRR of the 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under Rule XIV;

WHEREAS, the REHABILITATION OF MAIN FEEDER LINE FROM ATS ROOM TO MAIN PANEL OF ATI-CO MAIN BUILDING, not being an exemption, must necessarily pass through competitive bidding;

WHEREAS, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with an Approved Budget for the Contract Amounting **One Million One Hundred Thousand Pesos (Php 1,100,000.00)** on PhilGEPS Website (PHILGEPS REF. NO. 9813857/ ITB NO. ATI-CO-2023-07) and the ATI Website.

WHEREAS, in response to the said posting, two (2) prospective bidders bought the bidding documents from the BAC Secretariat and submitted their bid proposals during the bid opening held on June 26, 2023;

WHEREAS, during the Bid Opening, it was found out that having complied with all the eligibility/ technical and financial requirements, bidders were rated as "ELIGIBLE" to participate in the bidding and thus rated as "PASSED";

WHEREAS, the Technical Working Group (TWG) for Infrastructure conducted a careful examination, validation and verification of all eligibility documents, technical and financial documents required including post-qualification documents as required by RA 9184 and its Implementing Rules and Regulations (see attached TWG's Bid Evaluation Report and Post-Qualification Report);

WHEREAS, the Bid Amount as Calculated are as follows:

1. Declare **Syndtite Construction Corp.** as the **LOWEST CALCULATED AND RESPONSIVE BIDDER** for the **REHABILITATION OF MAIN FEEDER LINE FROM ATS ROOM TO MAIN PANEL OF ATI-CO MAIN BUILDING**;
2. Recommend for the approval of the award of the said Contract to **Syndtite Construction Corp.** and its Bid Amount as Calculated amounting to **Nine Hundred Thousand Four Hundred Eighteen Pesos and 05/100 Pesos (Php 900,418.05)**
3. Recommend for Approval by the ATI Director IV the foregoing findings/recommendations.
