

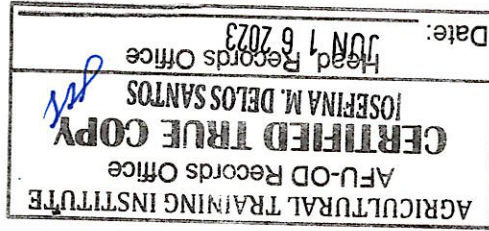
**CONTRACT AGREEMENT**

THIS AGREEMENT made the JUN 08 2023 day of 2023 between **AGRICULTURAL TRAINING INSTITUTE** of the Philippines (hereinafter called "the Entity") of the one part and **COVER AND PAGES CORPORATION** with office address at 2763 Silang St., Sta. Ana, Manila (hereinafter called "the Supplier") of the other part;


WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROCUREMENT OF PRINTING SERVICES FOR THE REPRODUCTION OF DIGITAL FARMERS PROGRAM MODULES, ATI CENTRAL OFFICE (PHIIGEPS Ref. No. 9653818/ITB-ATI-CO-2023-06)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SEVEN HUNDRED THIRTY-ONE THOUSAND EIGHT HUNDRED SIXTY-FIVE PESOS ONLY (P731,865.00)**. (Hereinafter called "the Contract Price")

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:



- i. Philippine Bidding Documents (PBDs);
  - i. Schedule of Requirements;
  - ii. Technical Specifications;
  - iii. General and Special Conditions of Contract; and
  - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.


3. In consideration for the sum of **SEVEN HUNDRED THIRTY-ONE THOUSAND EIGHT HUNDRED SIXTY-FIVE PESOS ONLY (P731,865.00)** or such other sums as may be ascertained, **COVER AND PAGES CORPORATION** agrees to the **PROCUREMENT OF PRINTING SERVICES FOR THE REPRODUCTION OF DIGITAL FARMERS PROGRAM MODULES, ATI CENTRAL OFFICE (PHIIGEPS Ref. No. 9653818/ITB-ATI-CO-2023-06)** in accordance with his/her/lits Bid.
4. The **AGRICULTURAL TRAINING INSTITUTE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


