A RESOLUTION RECOMMENDING APPROVAL TO ADOPT NEGOTIATED PROCUREMENT: AGENCY-TO-AGENCY AS THE ALTERNATIVE METHOD OF PROCUREMENT

Section 53.5 and Annex "H" D-5 of the 2016 Revised IRR of RA 9184

BAC Resolution No. PAO - 06-01, s. 2023

WHEREAS, as a general rule, all procurements shall be done through competitive bidding except whenever justified by the conditions in order to promote economy and efficiency, Agency may resort to any alternative method of procurement;

WHEREAS, one of the functions of BAC is to recommend to the Head of Procuring Entity (HOPE) the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;

WHEREAS, Section 48, Rule XVI: Alternative Methods of Procurement of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;

WHEREAS, the Partnerships and Accreditation Division prepared a Purchase Request with No. **PAD (RICE) FUND 2023-07-49** for the **Full Meal, Accommodation, Training Hall, and Vehicle Rental for the Instilling Knowledge on Strategic Rice-based Enterprise Clustering Approach: A Training of Trainers on Agro-enterprise Clustering Development on August 7-11, 2023 at Region X** with an Approved Budget for the Contract (ABC) of **P 413,000.00**, in accordance with its PPMP;

WHEREAS, the end-user has justified that resorting to Negotiated Procurement by Agency-to Agency is more efficient and economical to the government as indicated in the letter/justification to the BAC with supporting document from **Tieza-Gardens of Malasag Eco Tourism Village** as the Servicing Agency;

WHEREAS, Section 53.5 of the 2016 Revised IRR allows the procurement of Goods, Infrastructure Project and Consulting Services from another agency of the **GoP**;

WHEREAS, Annex "H" of the same IRR sets the conditions for the Agency-to-Agency enumerated as follows: (i) The Procuring Entity shall justify that entering into an Agency-to-Agency Agreement with the Servicing Agency is more efficient and economical to the government (ii) Servicing Agency has the mandate to deliver goods and services required to be procured or to undertake the infrastructure project or consultancy required by the Procuring Agency (iii) Servicing Agency has the absorptive capacity to undertake the project (iv) Servicing Agency owns or has access to the necessary tools and equipment required for the project;

NOW THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby **RESOLVE AS IT IS HEREBY RESOLVED to recommend Negotiated Procurement: Agency-to-Agency as the Alternative Method of Procurement to be adopted through the TIEZA-GARDENS OF MALASAG ECO TOURISM VILLAGE for the FULL MEAL, ACCOMMODATION, TRAINING HALL, AND VEHICLE RENTAL as stipulated in Section 53 and Annex H Section D-5 (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184 with contract amount of P 412,500.00.**
