A RESOLUTION RECOMMENDING APPROVAL TO ADOPT NEGOTIATED PROCUREMENT: AGENCY-TO-AGENCY AS THE ALTERNATIVE METHOD OF PROCUREMENT

Section 53.5 and Annex "H" D-5 of the 2016 Revised IRR of RA 9184

BAC Resolution No. 15D - 08-06, s. 2023

- WHEREAS, as a general rule, all procurements shall be done through competitive bidding except whenever justified by the conditions in order to promote economy and efficiency, Agency may resort to any alternative method of procurement;
- WHEREAS, one of the functions of BAC is to recommend to the Head of Procuring Entity (HOPE) the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;
- WHEREAS, Section 48, Rule XVI: Alternative Methods of Procurement of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement provided that the most advantageous price for the government will be obtained;
- WHEREAS, the INFORMATION SERVICES DIVISION prepared a Purchase Request with No. ISD Fund 2023-08-65 for Meals and accommodation in Ilocos Norte for participation at the International Congress on eLearning 2023 with an Approved Budget for the Contract (ABC) of Php 195,000.00, in accordance with its PPMP;
- WHEREAS, the end-user has justified that resorting to Negotiated Procurement by Agency-to Agency is more efficient and economical to the government as indicated in the letter/justification to the BAC with supporting document from Mariano Marcos State University as the Servicing Agency;
- **WHEREAS,** Section 53.5 of the 2016 Revised IRR allows the procurement of Goods, Infrastructure Project and Consulting Services from another agency of the GoP;
- WHEREAS, Annex "H" of the same IRR sets the conditions for the Agency-to-Agency enumerated as follows: (i) The Procuring Entity shall justify that entering into an Agency-to-Agency Agreement with the Servicing Agency is more efficient and economical to the government (ii) Servicing Agency has the mandate to deliver goods and services required to be procured or to undertake the infrastructure project or consultancy required by the Procuring Agency (iii) Servicing Agency has the absorptive capacity to undertake the project (iv) Servicing Agency owns or has access to the necessary tools and equipment required for the project;

NOW THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE AS IT HEREBY RESOLVED to recommend Negotiated Procurement: Agency-to-Agency as the Alternative Method of Procurement to be adopted through the MARIANO MARCOS STATE UNIVERSITY for MEALS AND ACCOMODATION with the amount of One Hundred Thirty-Eight Thousand Eight Hundred Forty Pesos Only (Php 138,840.00) as stipulated in Section 53 and Annex H Section D-5 (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of RA 9184.
