WHEREAS, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity abides by the standard set forth by the said act;

WHEREAS, Section 10, Rule IV of the IRR-A of the 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under the Rule XIV;

WHEREAS, the Procurement of Video Production of Agritalk 2 Easy Learning Series, ATI Central Office, not being an exemption, must necessarily pass through competitive bidding;

WHEREAS, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with an Approved Budget for the Contract Amounting to **One Million Four Hundred Ninety-Five Thousand Pesos (PHP 1,495,000.00)** on the PhilGEPS Website (ITB NO. ATI-CO-2023-09) and the ATI Website.

WHEREAS, in response to the said posting, three (3) bidders bought the bidding documents from the BAC Secretariat and submitted their bid proposals during the bid opening held on September 8, 2023;

WHEREAS, during the Bid Opening, all three (3) bidders are rated as “ELIGIBLE” to participate in the bidding and rated as “PASSED” having complied with all the eligibility/technical and financial requirements;

WHEREAS, the Technical Working Group (TWG) for Goods and Services conducted a careful examination, validation, and verification of all eligibility documents, technical and financial required including post-qualification documents as required by RA 9184 and its Implementing Rules and Regulations. **Yonzon Associates Incorporated** and **CESC.AB Talisman Inc.** are found non-responsive to the requirements and conditions specified in the bidding documents for the said project. (see attached BAC Resolution No. _____ and Post Qualification Report);

WHEREAS, the TWG conducted post-qualification of the next lowest bidder; La Oyay Studio was found responsive to the ATI requirements and conditions specified in the Bidding Documents (see attached TWG’s Post Qualification report);

WHEREAS, the Bid Amount as Calculated of **La Oyay Studio is One Million Four Hundred Forty-Five Thousand Pesos (Php 1,445,00.00)**;

WHEREAS, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG's recommendation, and declare **La Oyay Studio** as the **SINGLE RATED AND RESPONSIVE BIDDER**;

NOW, THEREFORE, in consideration of the foregoing, We, the Members of the Bids and Awards Committee, **hereby RESOLVE AS IT HEREBY RESOLVED** to:

1. Declare **LA OYAY STUDIO** as the **SINGLE RATED AND RESPONSIVE BIDDER** for the Procurement of Video Production of Agritalk 2 Easy Learning Series, ATI Central Office;
2. Recommend the award of the said Contract to **LA OYAY STUDIO** with its Bid Amount as Calculated amounting to **One Million Four Hundred Forty-Five Thousand Pesos Only (Php 1,445,000.00)**;
3. Recommend for Approval by the ATI Director IV the foregoing findings/recommendations.
