- WHEREAS, Republic Act No. 9184 otherwise known as "The Government Procurement Reform Act "created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity abides by the standard set forth by the said act;
- **WHEREAS**, Section 10, Rule IV of the IRR of the 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under Rule XIV;
- WHEREAS, the reconfiguration of the proposed office for the National Organic Agriculture Program at the 3rd Floor Left Wing of ATI-CO, Main Building, not being an exemption, must necessarily pass through competitive bidding;
- WHEREAS, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with an Approved Budget for the Contract Amounting to Three Million Three Hundred Thousand Pesos (Php 3,300,000.00) on PhilGEPS Website (PHILGEPS REF. NO. 10028251/ ITB NO. ATI-CO-2023-10) and the ATI Website.
- WHEREAS, in response to the said posting, four (4) prospective bidders bought the bidding documents from the BAC Secretariat and submitted their bid proposals during the bid opening held on September 8, 2023;

WHEREAS, during the Bid Opening, it was found out that having complied with all the eligibility/technical and financial requirements, bidders were rated as" ELIGIBLE" to participate in the bidding and thus rated as "PASSED":
