A RESOLUTION DECLARING M.P. EVANGELISTA CATERING SERVICES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF MEALS DURING THE PRE-DEPARTURE ORIENTATION COURSE (PDOC) OF YOUNG FILIPINO FARM LEADERS TRAINING PROGRAM IN JAPAN (YFFLTP) BATCH 2024 (PHILGEPS REF. NO. 10413829/ ITB NO.ATI-CO-2024-04)

BAC Resolution No. 02-01, s. 2024

WHEREAS, Republic Act No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity abides by the standard set forth by the said act;

WHEREAS, Section 10, Rule IV of the IRR-A of the 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under the Rule XIV;

WHEREAS, the Procurement of Meals for the Pre-Departure Orientation Course (PDOC) of the Young Filipino Farm Leaders Training Program in Japan (YFFLTP) Batch 2024, not being an exemption, must necessarily pass through competitive bidding;

WHEREAS, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with Approved Budget for the Contract Amounting to One Million Five Hundred Thirteen Thousand Two Hundred Pesos (Php 1,513,200.00) in PhilGEPS Website (PHILGEPS REF. NO. 10413829/ ITB NO.ATI-CO-2024-04) and the ATI Website.

WHEREAS, in response to the said posting, two (2) prospective bidders bought the bidding documents from the BAC Secretariat and submitted their bid proposals before the bid opening held on January 22, 2024:

1. M.P. Evangelista Catering Services
2. SD Publication

WHEREAS, during the Bid Opening, both bidders were found that having complied with all the eligibility/technical and financial requirements, bidders were rated as “ELIGIBLE” to participate in the bidding and thus rated as “PASSED”;

WHEREAS, the Technical Working Group (TWG) for Goods and Services conducted a careful examination, validation, and verification of all eligibility documents, technical and financial documents required including post-qualification documents as required by RA 9184 and its Implementing Rules and Regulations to the lowest bidder M.P. Evangelista Catering Services and found to be “Responsive” to ATI’s requirements (see attached Bid Evaluation Report and Post Qualification Report of BAC TWG) with a Bid Amount as Calculated amounting to One Million Three Hundred Forty Thousand One Hundred Fifty Pesos (Php 1,340,150.00);

WHEREAS, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG’s recommendation and declare M.P. Evangelista Catering Services as the LOWEST CALCULATED AND RESPONSIVE BIDDER;

NOW, THEREFORE, in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby **RESOLVE AS IT HEREBY RESOLVED** to:

1. Declare M.P. Evangelista Catering Services as the LOWEST CALCULATED AND RESPONSIVE BIDDER for the Procurement of Meals for the Pre-Departure Orientation Course (PDOC) of the Young Filipino Farm Leaders Training Program in Japan (YFFLTP) Batch 2024;

- 2. Recommend for the approval of the award of the said Contract to **M.P. Evangelista Catering Services** and its Bid Amount as Calculated amounting to **One Million Three Hundred Forty Thousand One Hundred Fifty Pesos Only (Php 1,340,150.00)**;
- 3. Recommend for Approval by the ATI Director IV the foregoing findings/ recommendations.
