WHEREAS, Republic Act (RA) No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity (PE) abides by the standard set forth by the said act;

WHEREAS, Section 10, Rule IV of the Implementing Rules and Regulations (IRR) of RA 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under Rule XIV;

WHEREAS, the procurement of meals; promotional materials and other supplies; and lights, sound, stage, and venue for the conduct of the **Horticultural and Urban Agriculture Summit**, not being an exemption, must necessarily pass through competitive bidding;

WHEREAS, the Agricultural Training Institute (ATI) posted the invitation to Bid for the aforementioned Project with an Approved Budget for the Contract (ABC) amounting to **Six Million Three Hundred Eighty Thousand Nine Hundred Pesos Only (Php 6,380,900.00)** in the Philippine Government Electronic Procurement System (PhilGEPS) Website (PhilGEPS Ref. No. 10673224/ITB No. ATI-CO-2024-07) and the ATI Website;

WHEREAS, in response to the said posting, the following bidders bought the bidding documents from the BAC Secretariat and submitted their bid proposals before the bid opening held on April 8, 2024:

2. Recommend for the approval of the award of the said Contract to **Post Ad Ventures, Inc.** and its Bid Amount as calculated amounting to **Two Million Nine Hundred Three Thousand Forty Pesos Only (Php 2,903,040.00);** and
3. Recommend for Approval by the ATI Director IV of the foregoing findings and recommendations.
