A RESOLUTION DECLARING M.P. EVANGELISTA CATERING SERVICES AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF MEALS FOR THE PRE-DEPARTURE ORIENTATION COURSE (PDOC) OF THE FILIPINO YOUNG FARMERS INTERNSHIP PROGRAM IN TAIWAN (FYFIPT) BATCH 4
(ITB-ATI-CO-2024-11/PhilGEPS Ref. No. 10706896)

BAC Resolution No. 05-01, series of 2024

WHEREAS, Republic Act (RA) No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity (PE) abides by the standard set forth by the said act;

WHEREAS, Section 10, Rule IV of the Implementing Rules and Regulations (IRR) of RA 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under Rule XIV;

WHEREAS, the **Procurement of Meals for the PDOC of the FYFIPT Batch 4**, not being an exemption, must necessarily pass through competitive bidding;

WHEREAS, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with an Approved Budget for the Contract (ABC) amounting to **Two Million Two Hundred Eighty-Nine Thousand Six Hundred Pesos Only (Php 2,289,600.00)** in the Philippine Government Electronic Procurement System (PhilGEPS) Website (PhilGEPS Ref. No. 10706896/ITB No. ATI-CO-2024-11) and the ATI Website;

WHEREAS, in response to the said posting, two (2) prospective bidders bought the bidding documents from the BAC Secretariat, namely M.P. Evangelista Catering Services and SD Publications Inc., but only M.P. Evangelista Catering Services submitted a bid proposal before the bid opening held on April 22, 2024;

WHEREAS, during the Bid Opening, only M.P. Evangelista Catering Services was found compliant with the eligibility/technical and financial requirements and was declared as “**ELIGIBLE**” to participate in the bidding and thus rated as “**PASSED**,” since SD Publications Inc. did not meet the deadline for the submission of bids;

WHEREAS, the Technical Working Group (TWG) for Goods and Services conducted a careful examination, validation, and verification of all eligibility documents technical and financial documents required including post-qualification documents as required by RA 9184 and its IRR to the sole eligible bidder M.P. Evangelista Catering Services and found to be “**Responsive**” to the ATI’s requirements (see *attached Bid Evaluation Report and Post Qualification Evaluation Report of BAC TWG*) with a Bid Amount as Calculated amounting to One Million Eight Hundred Twelve Thousand Six Hundred Pesos Only (Php 1,812,600.00);

WHEREAS, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG’s recommendation and declare **M.P. Evangelista Catering Services** as the **SINGLE CALCULATED AND RESPONSIVE BIDDER**;

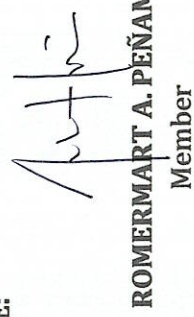
NOW, THEREFORE, in consideration of the foregoing, We, the BAC Members, hereby **RESOLVE AS IT HEREBY RESOLVED** to:

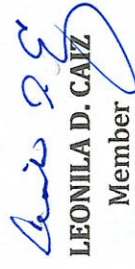
