**A RESOLUTION DECLARING ULTRA SECURITY SERVICES, INC. AS THE LOWEST CALCULATED
AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF SECURITY SERVICES**

FOR JUNE 1, 2024 – MAY 31, 2025

(ITB-ATI-CO-2024-12/PhilGEPS Ref. No. 10722007)

BAC Resolution No. 02-02, series of 2024

WHEREAS, Republic Act (RA) No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity (PE) abides by the standard set forth by the said act;

WHEREAS, Section 10, Rule IV of the Implementing Rules and Regulations (IRR) of RA 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under Rule XIV;

WHEREAS, the **Procurement of Security Services for the Period of June 1, 2024 to May 31, 2025**, not being an exemption, must necessarily pass through competitive bidding;

WHEREAS, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with an Approved Budget for the Contract (ABC) amounting to **Six Million Six Hundred Thirty-Four Thousand Six Hundred Seventeen Pesos and 21/100 only (Php 6,634,617.21)** in the Philippine Government Electronic Procurement System (PhilGEPS) Website (PhilGEPS Ref. No. 10722007/ITB No. ATI-CO-2024-12) and the ATI Website;

WHEREAS, in response to the said posting, the following three (3) prospective bidders bought the bidding documents from the BAC Secretariat and submitted a bid proposal before the bid opening held on May 3, 2024:

1. Ultra Security Services, Inc.
2. Urduja Security Services, Inc.
3. Vigilant Investigative and Security Agency, Inc.

WHEREAS, during the Bid Opening, it was found out that having complied with the eligibility/technical and financial requirements, all bidders were declared as “**ELIGIBLE**” to participate in the bidding and thus rated as “**PASSED**”;

WHEREAS, the Technical Working Group (TWG) for Utility and Security Services conducted a careful examination, validation, and verification of all eligibility documents technical and financial documents required including post-qualification documents as required by RA 9184 and its IRR to the lowest eligible bidder, Ultra Security Services, Inc. and found to be “**Responsive**” to the ATI’s requirements (see attached *Bid Evaluation Report and Post Qualification Evaluation Report of BAC TWG*) with a Bid Amount as Calculated amounting to Six Million Two Hundred Fifty-Nine Thousand Six Hundred Fifty-One Pesos and 8/100 only (Php 6,259,651.08);

WHEREAS, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG's recommendation and declare **Ultra Security Services, Inc.** as the **LOWEST CALCULATED AND RESPONSIVE BIDDER**;

NOW, THEREFORE, in consideration of the foregoing, We, the BAC Members, hereby **RESOLVE AS IT HEREBY RESOLVED** to:

1. Declare **Ultra Security Services, Inc.** as the **Lowest Calculated and Responsive Bidder** for the **Procurement of Security Services for the Period of June 1, 2024 to May 31, 2025**;
2. Recommend for the approval of the award of the said Contract to **Ultra Security Services** and its Bid Amount as calculated amounting to **Six Million Two Hundred Fifty-Nine Thousand Six Hundred Fifty-One Pesos and 8/100 only (Php 6,259,651.08)**; and
3. Recommend for Approval by the ATI Director IV of the foregoing findings and recommendations.
