- WHEREAS, the Agricultural Training Institute (ATI) Director/Head of Procuring Entity (HoPE) had approved Purchase Request (P.R.) No. PAD FUND 2024-05-46 to procure Logistics (3 days, 5 vans) to fetch and ferry the participants and Training Management Team for the activity entitled "Training of Trainers on Soybean Production and Postharvest Management" on June 17 21, 2024, from airport to venue and the University of the Philippines Los Baños (UPLB), Laguna with an Approved Budget for the Contract (ABC) user's Project Procurement Management Plan (PPMP); amounting of Seventy Thousand Pesos only (Php 70,000.00) in accordance with the End-
- WHEREAS, as a general rule, all procurement shall be done through competitive bidding except to any alternative method of procurement; whenever justified by the conditions in order to promote economy and efficiency, may resort
- WHEREAS, one of the functions of the Bids and Awards Committee (BAC) is to recommend to the HoPE the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;
- WHEREAS, the above cited P.R. of Logistics, is not covered by Shopping under Section 52 of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;
- WHEREAS, the amount involved is within the threshold of Negotiated Procurement Small Value Procurement as an Alternative Method of Procurement indicated in Annex "H" of the 2016 Revised IRR of RA 9184 for National Government Agencies (NGAs);
- WHEREAS, invitations be posted thru the Philippine Government Electronic Procurement System qualifications; requests for quotations/proposals to suppliers, (PhilGEPs) and procurement entity's website and other conspicuous places and send three (3) requests for quotations/proposals to suppliers, contractor, and consultants of known
- WHEREAS, the receipt of one (1) quotation/proposal is sufficient to proceed with the evaluation thereof;
- WHEREAS, ATI ensures that the objectives and purpose of the procurement do not constitute an unnecessary, excessive, extravagant, or unconscionable expenditure;
- WHEREAS, ATI-BAC shall validate the technical, legal and financial capability of the supplier/s by submission of relevant documents or through other means of exercising due diligence prior to the recommendation of award to the HoPE

NOW THEREFORE, in the consideration of the foregoing, We, the BAC Members, hereby RESOLVE AS IT HEREBY RESOLVED to: Recommend Alternative Method of Procurement through Negotiated Procurement

Small Value Procurement as provided in Sec. 53.9 and Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised IRR of services; and 9184 for the above-cited goods/services/infrastructure projects/consulting
