- WHEREAS, the Agricultural Training Institute (ATI) has approved the Purchase Request (P.R.) No. ADMIN FUND 2024-05-88 for the lease of venue with meals, accommodations, and other services for the conduct of the Values Restoration Program on June 19-21, 2024 with an Approved Budget for the Contract (ABC) amounting to Seventy-Five Thousand Five Hundred Fifty Pesos only (Php 75,550.00) in accordance to the approved End-user's Project Procurement Management Plan (PPMP);
- WHEREAS, as a general rule, all procurement shall be done through competitive bidding except to any alternative method of procurement; whenever justified by the conditions in order to promote economy and efficiency, may resort
- WHEREAS, one of the functions of the Bids and Awards Committee (BAC) is to recommend to the actual conditions and to ensure that the same is most advantageous to the government; Head of Procuring Entity (HoPE) the mode of procurement to be undertaken to meet the
- WHEREAS, specifications and terms is within the coverage of Section 53. 10 and Annex "H" D-9 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;
- WHEREAS, as a general rule for alternative methods of procurement, advertisement, and posting as Section 54.2 of the IRR; prescribed in Section 21.2.1 of the IRR, may be dispensed with, except those provided in
- WHEREAS, quotations/proposals to suppliers of known qualifications; the BAC through its procurement coordinator send three \Im requests for
- WHEREAS, the receipt of 1 quotation/proposal is sufficient to proceed with the evaluation thereof;
- WHEREAS, the supplier with lowest quotation/proposal must undergo and rated according to Table of Rating Factors for Lease of Venue as indicated in the Annex H, Appendix B, Table C of the 2016 Revised IRR of RA 9184 for the determination of reasonableness of rental rates.
- WHEREAS, ATI ensures that the objectives and purpose of the procurement do not constitute an unnecessary, excessive, extravagant, or unconscionable expenditure;
- WHEREAS, ATI-BAC shall validate the technical, legal, and financial capability of the supplier/s by to the recommendation of award to the HoPE submission of relevant documents or through other means of exercising due diligence prior
