A RESOLUTION DECLARING KAIFASHION PHILIPPINES INC. AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF TRAINING MATERIALS/SUPPLIES (LOT 1) (ITB-ATI-CO-2024-09/PhilGEPS Ref. No. 10702945)

BAC Resolution No. QC-05, series of 2024

WHEREAS, Republic Act (RA) No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity (PE) abides by the standard set forth by the said act;

WHEREAS, Section 10, Rule IV of the Implementing Rules and Regulations (IRR) of RA 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under Rule XIV;

WHEREAS, the **Procurement of Training Materials/Supplies** which will be used for the production of information, education, and communication (IEC) and other promotional materials, not being an exemption, must necessarily pass through competitive bidding;

WHEREAS, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with an Approved Budget for the Contract (ABC) amounting to **Six Hundred Forty Thousand Pesos only (Php 640,000.00)** in the Philippine Government Electronic Procurement System (PhilGEPS) Website (PhilGEPS Ref. No. 10702945/ITB No. ATI-CO-2024-09) and the ATI Website;

WHEREAS, in response to the said posting, the following eight (8) prospective bidders bought the bidding documents from the BAC Secretariat and submitted a bid proposal before the bid opening held on April 22, 2024:

1. Grafiq Advertising System Corp.
2. Happy Boutique
3. Kaifashion Philippines Inc.
4. Light Energy Enterprise
5. Meraki Digital Printing Services
6. NDJ Enterprise Corp.
7. Primoway Specialized Goods Trading
8. Tanjur Enterprises

WHEREAS, during the Bid Opening, it was found out that having complied with the eligibility/technical and financial requirements, all bidders were declared as “**ELIGIBLE**” to participate in the bidding and thus rated as “**PASSED**”;

WHEREAS, the Technical Working Group (TWG) for Goods and Services conducted a careful examination, validation, and verification of all eligibility documents technical and financial documents required including post-qualification documents as required by RA 9184 and its IRR to the lowest eligible bidder, **Kaifashion Philippines Inc.** and found to be **“Responsive”** to the ATI’s requirements (*see attached Bid Evaluation Report and Post Qualification Evaluation Report of BAC TWG*) with a bid amount as calculated amounting to Three Hundred Twelve Thousand Eighty Pesos only (Php 312,080.00);

WHEREAS, based on the TWG’s report there is a discrepancy in Kaifashion Philippines Inc.’s submitted bid amount, wherein the bid amount as read (Php 312,000.00) is different from the bid amount as calculated (Php 312,080.00);

WHEREAS, Section 34.4 of the IRR of RA 9184 provides that the amount of award of contract to the bidder with the Lowest Calculated Responsive Bid (LCRB) or Highest Rated Responsive Bid (HRRB) shall be at its submitted bid price or its calculated bid price whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower;

WHEREAS, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG’s recommendation and declare **Kaifashion Philippines Inc.** as the **LOWEST CALCULATED AND RESPONSIVE BIDDER** with a contract price of Three Hundred Twelve Thousand Pesos only (Php 312,000.00), as this is lower than the calculated bid price;

NOW, THEREFORE, in consideration of the foregoing, We, the BAC Members, *hereby RESOLVE AS IT HEREBY RESOLVED* to:

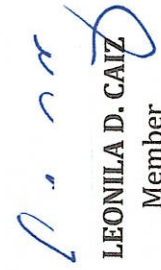
1. Declare **Kaifashion Philippines Inc.** as the **Single Calculated and Responsive Bidder** for the **Procurement of Training Materials and Supplies (Lot 1)**;
2. Recommend for the approval of the award of the said Contract to **Kaifashion Philippines Inc.** and its Bid Amount as Read amounting to **Three Hundred Twelve Thousand Pesos only (Php 312,000.00)**; and
3. Recommend for Approval by the ATI Director IV of the foregoing findings and recommendations.
