INVITATION FOR NEGOTIATED PROCUREMENT FOR TWO (2)-FAILED BIDDING Procurement of Passenger Van

1. The Agricultural Training Institute (ATI) through its Bids and Awards Committee (BAC), intends to procure Passenger Van with an ***Approved Budget for the Contract (ABC) amounting to Three Million One Hundred Seventy-Five Thousand Pesos Only (Php 3,175,000.00).***
2. The ATI BAC now invites technically, legally, and financially capable suppliers for the said project.
3. The procurement procedure for this requirement is Negotiated Procurement for Two (2)-Failed Bidding pursuant to Section 53.1 of 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. The selection of the successful offer shall be based on the best and final offer that will be submitted on the set deadline to the BAC and which would meet the minimum technical specifications required.
5. The interested bidders may obtain further information from the BAC Secretariat at the address given below from ***12 July 2024 to 22 July 2024, Monday to Friday, 8:00 AM to 5:00 PM.***

7. Interested Bidders are required to submit in sealed envelopes, one (1) original copy and two (2) copies of the following to the ATI BAC Secretariat Office on or before ***July 22, 2024, at 9:00 am***, ATI Bldg., Elliptical Road, Diliman, Quezon City. Late submissions shall not be accepted.

A. Eligibility and Technical Documents

- a) Valid PhilGEPS Registration Certificate (Platinum Membership), including the Annex/es;
- b) Statement of Bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid. For this purpose, the definition of similar contracts shall refer to Procurement of Passenger Van which shall be completed within the last five (5) years prior to the date of submission of the best and final offer.

- c) Bid Security in any of the following form as prescribed under the 2016 revised IRR of RA 9184:
 - i. In case of cash, Manager's Check, Bank Guarantee (2% of the ABC or PhP 63,500.00)
 - ii. In the case of Surety Bond, submit also a certification issued by the Insurance Commission (5% of the ABC or PhP158,750.00)
 - iii. Original Copy Notarized Bid Securing Declaration
- d) Conformity with the Schedule of Requirements
- e) Conformity with the Technical Specifications
- f) Notarized Omnibus Sworn Statement (OSS) supported with Notarized Secretary's Certificate in case of a corporation or cooperative; in case of partnership or single proprietorship, the bidder shall submit Special Power of Attorney executed by the partners or single proprietorship; whichever is applicable. In case of a Joint Venture, Special Power of Attorney shall be submitted by all members of the joint venture giving full power and authority to its officer to sign the OSS and do acts to represent the Bidder.
- g) If applicable, a duly signed joint venture agreement (JVA) in case the joint venture is already in existence or a duly notarized statement from all the potential joint venture partners stating that they will enter into and abide by the provisions of the JVA in the instance that the bid is successful.
