**A RESOLUTION DECLARING DEOKMA EIGHT TRADING, INC. AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF SUPPLY OF EQUIPMENT, LABOR, AND INSTALLATION OF BRAND-NEW AIR-CONDITIONING UNITS (ACU) FOR REPLACEMENT OF WORN OUT ACU IN DIFFERENT OFFICES IN ATI-CENTRAL OFFICE (ITB-ATI-CO-2024-19/PhilGEPS Ref. No. 10971534)**

**WHEREAS**, Republic Act (RA) No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity (PE) abides by the standard set forth by the said act;

**WHEREAS**, Section 10, Rule IV of the Implementing Rules and Regulations (IRR) of RA 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under Rule XIV;

**WHEREAS**, the **Procurement of Supply of Equipment, Labor, and Installation of Brand-New ACUs for Replacement of Worn Out ACUs in Different Offices in ATI-Central Office**, not being an exemption, must necessarily pass through competitive bidding;

**WHEREAS**, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with an Approved Budget for the Contract (ABC) amounting to **One Million Six Hundred Seventy-Five Thousand Five Hundred Forty-Three Pesos and 35/100 only (Php 1,675,543.35)**, in the Philippine Government Electronic Procurement System (PhilGEPS) Website (PhilGEPS Ref. No. 10971534/ITB No. ATI-CO-2024-19) and the ATI Website;

**WHEREAS**, in response to the said posting, two (2) prospective bidders namely Deokma Eight Trading, Inc. and R BROS Enterprises bought the bidding documents from the BAC Secretariat and submitted their bid proposals before the bid opening held on July 12, 2024;

**WHEREAS**, during the Bid Opening, it was found out that having complied with the eligibility/technical and financial requirements, the two (2) bidders were declared as **“ELIGIBLE”** to participate in the bidding and thus rated as **“PASSED”**;

**WHEREAS**, the Technical Working Group (TWG) for Goods and Services conducted a careful examination, validation, and verification of all eligibility documents technical and financial documents required including post-qualification documents as required by RA 9184 and its IRR to the lowest eligible bidder, **Deokma Eight Trading, Inc.** and found to be **“Responsive”** to the ATI’s requirements with a Bid Amount as Calculated amounting to **One Million Two Hundred Forty-Eight Thousand Pesos only (Php 1,248,000.00)**. *(see attached Bid Evaluation Report and Post Qualification Evaluation Report of BAC TWG)*;

WHEREAS, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG's recommendation and declare Deokma Eight Trading, Inc. as the **LOWEST CALCULATED AND RESPONSIVE BIDDER**;

**NOW, THEREFORE**, in consideration of the foregoing, We, the BAC Members, hereby **RESOLVE AS IT HEREBY RESOLVED** to:

1. Declare Deokma Eight Trading, Inc. as the Lowest Calculated and Responsive Bidder for the Supply of Equipment, Labor, and Installation of Brand-New ACUs for Replacement of Worn Out ACUs in Different Offices in ATI-Central Office;
2. Recommend for the approval of the award of the said Contract to Commerce First, Inc. and its Bid Amount as calculated amounting to **One Million Two Hundred Forty-Eight Thousand Pesos only (Php 1,248,000.00)**; and
3. Recommend for Approval by the ATI Director IV of the foregoing findings and recommendations.
