CONTRACT AGREEMENT

THIS AGREEMENT was made on the AUG 06 2024 day of _____ 2024 between **AGRICULTURAL TRAINING INSTITUTE** of the Philippines (hereinafter called "the Entity") of the one part and **LA OYAY STUDIO** with office address at *Fundado St. Zone 7 Sagrada, Pili, Camarines Sur* (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROCUREMENT OF VIDEO PRODUCTION OF AGRITALK 2-EASY LEARNING SERIES (PHILGEPS REF. NO. 10649208/ITB-ATI-CO-2024-06)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION FIFTY THOUSAND PESOS ONLY (Php 1,050,000.00)** (Hereinafter called "the Contract Price").

 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the Government Procurement Policy Board (GPPB) that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **ONE MILLION FIFTY THOUSAND PESOS ONLY (Php 1,050,000.00)** or such other sums as may be ascertained, **LA OYAY STUDIO** agrees to **PROCUREMENT OF VIDEO PRODUCTION OF AGRITALK 2-EASY LEARNING SERIES (PHILGEPS REF. NO. 10649208/ITB-ATI-CO-2024-06)** in accordance with his/her/its Bid.

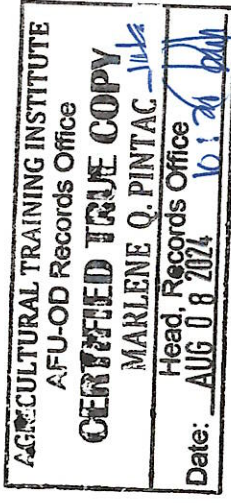
