A RESOLUTION RECOMMENDING APPROVAL FOR ADOPTING ALTERNATIVE METHOD OF PROCUREMENT - NEGOTIATED PROCUREMENT - LEASE OF REAL PROPERTY AND VENUE AWARD TO TIEZA – GARDENS OF MALASAG ECO TOURISM VILLAGE

Section 53.10 and Annex “H” D-9 of 2016 Revised IRR of RA 9184

BAC Resolution No. CDMD-06-05, s. 2024

WHEREAS, the Agricultural Training Institute Director/Head of Procuring Entity (HoPE) had approved Purchase Request (P.R.) No. **CDMD FUND 2024-08-36** for lease of venue with meals, accommodations, use of training hall and equipment, and other services to be utilized during the **conduct of Consultation Workshop on the Master in Public Management Major in Rural Development (MPM-RD) Scholarship Program on August 27-20, 2024**, with an Approved Budget for the Contract (ABC) of **Two Hundred Fifty-Two Thousand Pesos Only (Php 252,000.00)** in accordance to the End-user’s Project Procurement Management Plan (PPMP);

WHEREAS, as a general rule, all procurement shall be done through competitive bidding except whenever justified by the conditions to promote economy and efficiency, may resort to any alternative method of procurement;

WHEREAS, one of the functions of Bids and Awards Committee (BAC) is to recommend to the HoPE the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;

WHEREAS, the above cited nature of P.R. based on its corresponding specifications and terms is within the coverage of Section 53.10 and Annex “H” D-9 of 2016 Revised IRR of RA 9184;

WHEREAS, as a general rule for alternative methods of procurement, advertisement and posting as prescribed in Section 21.2.1 of the IRR, may be dispensed with, except those provided in Section 54.2 of the IRR;

WHEREAS, BAC through its procurement coordinator send three (3) requests for quotations/proposals to suppliers of known qualifications;

WHEREAS, the receipt of one (1) quotation/proposal is sufficient to proceed with the evaluation thereof;

WHEREAS, the supplier with lowest quotation/proposal must undergo and rated according to Table of Rating Factors for Lease of Venue as indicated in the Annex H, Appendix B, Table C of the 2016 Revised IRR of RA 9184 for the determination of reasonableness of rental rates;

WHEREAS, ATI ensures that the objectives and purpose of the procurement do not constitute an unnecessary, excessive, extravagant, or unconscionable expenditure;

WHEREAS, ATI-BAC shall validate the technical, legal and financial capability of the supplier/s by submission of relevant documents or through other means of exercising due diligence prior to the recommendation of award to the HoPE;

WHEREAS, upon validation, the Gardens of Malasag Eco Tourism Village which is a property of the Tourism Infrastructure and Enterprise Zone Authority (TIEZA), a Government Owned and Controlled Corporation (GOCC) attached to the Department of Tourism (DOT) declared as the lowest and responsive bidder for the abovementioned procurement.


