

**CONTRACT AGREEMENT**

**04 SEP 2024**

THIS AGREEMENT was made on the 04 SEP 2024 day of 2024 between **AGRICULTURAL TRAINING INSTITUTE** of the Philippines (hereinafter called "the Entity") of the one part and **DEOKMA EIGHT TRADING INC.** with office address at *Unit 1 Greenhills Product Compound, M.L. Quezon St., Casuntingan, Mandaue City, Cebu* (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **PROCUREMENT OF THE SUPPLY OF EQUIPMENT, LABOR AND INSTALLATION OF BRAND-NEW AIR-CONDITIONING UNITS (ACU) FOR REPLACEMENT OF WORN-OUT ACU IN DIFFERENT OFFICES IN ATI-CENTRAL OFFICE (PhiIGEPS Ref. No. 10971534/ITB-ATI-CO-2024-19)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION TWO HUNDRED FORTY-EIGHT THOUSAND PESOS ONLY (Php 1,248,000.00)** (Hereinafter called "the Contract Price").

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement, words and expressions shall have the same meanings as those assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
  - ii. Schedule of Requirements;
  - iii. Technical Specifications;
  - iv. General and Special Conditions of Contract; and Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the Government Procurement Policy Board (GPPB) that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **ONE MILLION TWO HUNDRED FORTY-EIGHT THOUSAND PESOS ONLY (Php 1,248,000.00)** or such other sums as may be ascertained, **DEOKMA EIGHT TRADING INC.** agrees to the **PROCUREMENT OF THE SUPPLY OF EQUIPMENT, LABOR AND INSTALLATION OF BRAND-NEW AIR-CONDITIONING UNITS (ACU) FOR REPLACEMENT OF WORN-OUT ACU IN DIFFERENT OFFICES IN ATI-CENTRAL OFFICE (PhiIGEPS Ref. No. 10971534/ITB-ATI-CO-2024-19)** in accordance with his/her/its Bid.

4. The **AGRICULTURAL TRAINING INSTITUTE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.



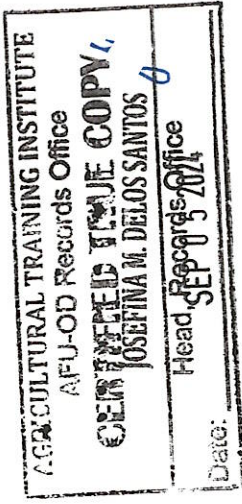
