

CONTRACT AGREEMENT

THIS AGREEMENT was made on the 04 day of SEP 2024 between **AGRICULTURAL TRAINING INSTITUTE** of the Philippines (hereinafter called "the Entity") of the one part and **GREEN OPTIONS AGRICULTURAL AND ENVIRONMENTAL BUSINESS CENTER** with office address at 299 Sitio Silangan, Cawongan, Padre Garcia, Batangas (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **PROCUREMENT OF THE URBAN AGRICULTURE SEEDS, FERTILIZER, SOIL, VERMI, TOOLS AND EQUIPMENT LOT 1 AND 2 (PhiIGEPS Ref. No. 10971640/ITB-ATI-CO-2024-17)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO MILLION THREE HUNDRED SIXTY-THREE THOUSAND NINE HUNDRED FORTY-TWO PESOS AND 40/100 (Php 2,363,942.40)** (Hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as those assigned to them in the Conditions of Contract referred to.
 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - ii. Schedule of Requirements;
 - iii. Technical Specifications;
 - iv. General and Special Conditions of Contract; and Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
- Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the Government Procurement Policy Board (GPPB) that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **TWO MILLION THREE HUNDRED SIXTY-THREE THOUSAND NINE HUNDRED FORTY-TWO PESOS AND 40/100 (Php 2,363,942.40)** or such other sums as may be ascertained, **GREEN OPTIONS AGRICULTURAL AND ENVIRONMENTAL BUSINESS CENTER** agrees to the **PROCUREMENT OF THE URBAN AGRICULTURE SEEDS, FERTILIZER, SOIL, VERMI, TOOLS AND EQUIPMENT LOT 1 AND 2 (PhiIGEPS Ref. No. 10971640/ITB-ATI-CO-2024-17)** in accordance with his/her/its Bid.

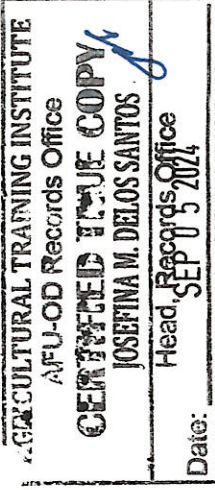
