A RESOLUTION DECLARING MAROONSTUDIOS INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF GOOGLE WORKSPACE ANNUAL SUBSCRIPTION RENEWAL

(ITB-ATI-CO-2024-22/PhilGEPS Ref. No. 11062665)

BAC Resolution No. 09-03, series of 2024

WHEREAS, Republic Act (RA) No. 9184 otherwise known as “The Government Procurement Reform Act” created the Bids and Awards Committee (BAC) to ensure among others that the Procuring Entity (PE) abides by the standard set forth by the said act;

WHEREAS, Section 10, Rule IV of the Implementing Rules and Regulations (IRR) of RA 9184 provides that all procurement shall pass through competitive bidding except as otherwise provided for under Rule XIV;

WHEREAS, the **Procurement of Google Workspace Annual Subscription Renewal**, not being an exemption, must necessarily pass through competitive bidding;

WHEREAS, the Agricultural Training Institute (ATI) posted the Invitation to Bid for the aforementioned Project with an Approved Budget for the Contract (ABC) amounting to **Three Million Four Hundred Thousand One Hundred Fifty Pesos only (Php 3,400,150.00)**, in the Philippine Government Electronic Procurement System (PhilGEPS) Website (PhilGEPS Ref. No. 11062665/ITB No. ATI-CO-2024-22) and the ATI Website;

WHEREAS, in response to the said posting, only one (1) prospective bidder, MaroonStudios Incorporated bought the bidding documents from the BAC Secretariat and submitted its bid proposals before the bid opening held on August 12, 2024;

WHEREAS, during the Bid Opening, it was determined that **MaroonStudios Inc.**, having complied with the eligibility/technical, and financial requirements, with a bid amount as read of Three Million Two Hundred Seventeen Thousand Eight Hundred Eighty-Three Pesos and 46/100 (Php 3,217,883.46), was declared “**ELIGIBLE**” to participate in the bidding and was thus rated as “**PASSED**”;

WHEREAS, the Technical Working Group (TWG) for Goods and Services conducted a careful examination, validation, and verification of all eligibility documents technical and financial documents required including post-qualification documents as required by RA 9184 and its IRR to the sole eligible bidder, **MaroonStudios Inc.** and found to be “**Responsive**” to the ATI’s requirements with a Bid Amount as Calculated amounting to Three Million Two Hundred Seventeen Thousand Eight Hundred Eighty-Three Pesos and 46/100 only (Php 3,217,883.46) (see attached Bid Evaluation Report and Post Qualification Evaluation Report of BAC TWG);






WHEREAS, the BAC further evaluated the aforementioned bid proposal and agreed to adopt the TWG’s recommendation and declare **MaroonStudios Inc.** as the **SINGLE CALCULATED AND RESPONSIVE BIDDER**;

NOW, THEREFORE, in consideration of the foregoing, We, the BAC Members, hereby **RESOLVE AS IT HEREBY RESOLVED** to:

1. Declare **MaroonStudios Inc.** as the **Single Calculated and Responsive Bidder** for the **Google Workspace Annual Subscription Renewal**;
2. Recommend for the approval of the award of the said Contract to **MaroonStudios Inc.** and its Bid Amount as calculated amounting to **Three Million Two Hundred Seventeen Thousand Eight Hundred Eighty-Three Pesos and 46/100 only (Php 3,217,883.46)**; and
3. Recommend for Approval by the ATI Director IV of the foregoing findings and recommendations.
