AMENDMENT TO AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Agreement, made and entered into at Pasay City, Philippines, on this 27th day of January 2025, by and between:

PHILIPPINE INTERNATIONAL CONVENTION CENTER, INC., a corporation duly organized and existing under Philippine law, with principal office at the PICC Complex located at 1307 Pasay City Metro Manila, represented herein by its General Manager, **NICOLETTE ANN P. CRUZ**, hereinafter referred to as the **"FIRST PARTY,"**

- and the -

DA – AGRICULTURAL TRAINING INSTITUTE, a government agency, with office address at Elliptical Road, Vasra, Quezon City, and represented herein by its Director IV, **REMELYN R. RECOTER, MNSA, CESO III**, hereinafter referred to as the **"SECOND PARTY";**

WITNESSETH: THAT -

WHEREAS, on 24 January 2025, the **FIRST PARTY** and the **SECOND PARTY** entered into an Agreement, hereinafter referred to as the "Original Agreement", for the use of PICC facilities for the event entitled, **ATI 38TH FOUNDING ANNIVERSARY** on **January 31, 2025** with estimated aggregate charges of **802,470.00** (Aggregate Charges plus VAT, exclusive of Security Deposit); and

WHEREAS, the **SECOND PARTY** has informed the **FIRST PARTY** about the change in event date from January 31, 2025 to January 29, 2025.

NOW, THEREFORE, premises considered, the parties hereto have agreed to amend the 2nd "Whereas" clause of the Original Agreement and its Contract Annex, as follows:

*Whereas, the **SECOND PARTY** desires to hold an event, "**ATI 38TH FOUNDING ANNIVERSARY**" (hereinafter referred to as the "Event") on **January 29, 2025** at the PICC Complex, and has accordingly proposed to lease from the **FIRST PARTY** certain room/s, space/s or area/s at the PICC Complex that is set/are set forth in Annex A hereof, and made an integral part hereof (herein referred to as the "Venue");*

All other provisions and stipulations in the Original Agreement not amended by this Agreement shall remain in full force and effect.
